PAYING STAT HOLIDAYS

The required practice is to pay Stat holidays when they fall rather than pay as you go.

With Labour Day approaching, here's a quick refresher

- Enter the STAT (Alternate Day)
 Pay Type for each employee on a tally sheet line or employee payslip
- **2.** The system calculates the rest using the employees average daily pay over the past 52 weeks.
- **3.** Qty/Hours, Rate, Gross and Days all automatically calculate (these can be overtyped)
- 4. Done

OFFICE STUFF

In the course of the last month while helping our customers online, we have noticed a couple of practices that are worth mentioning.

- Staff base rates MUST be the legal minimum rate or above
- Those on a 'Total Rem' basis, the base rate must be minimum + 3%
- When changing rates via Update Rates, only select the correct pay types, not all
- When sending payroll files to IRD or ATO, print preview and check first
- Australia—Add Super to ALL employees before their first pay
- Australlia—To avoid Super-Stream errors every Super pay type MUST have a Super Fund set and a Contribution Type eg Standard, Salary Sacrifice etc

Late filing or non-filing: Penalties and notifications

This week IRD will be identifying employers who have filed late with a due date in September and later next week, employers who haven't filed at all for September.

These employers will get a penalty notice.

Month End

This is an important practice at the end of each month—it rolls over all your data to the current working period keeping everything current.

Tools > Month End > Period End
